# **GREATER FRENCHTOWN/SOUTHSIDE (GFS)**



Bond Community Health Clinic - 1549 S Monroe St The Bond Community Health Center, Inc. (Bond CHC) has requested approximately \$160,000 in funding from the CRA for proposed improvements to the exterior and interior of the property located at 1549 S Monroe St. The cost, fees and proposed improvements include architectural fees, permitting, demolition, modifications to the present HVAC unit including new ductwork, constructing new interior walls, and renovating restrooms to current American for Disabilities Act (ADA) standards. Plus, construction of a pharmacy drive thru window with an overhead canopy. The project was approved for recommendation to the CRA Board by the Greater Frenchtown/Southside Citizens Advisory Committee (GFS CAC) at the June 10, 2024 GFS CAC meeting. The approximately \$160,000 funding request will be presented to the CRA Board as an agenda item at the August 22, 2024 meeting.



Osceola Street Sidewalk Project

The City of Tallahassee Underground Utilities and Public Infrastructure (UUPI) Department has requested \$600,000 in funding from the CRA to design and construct a sidewalk within the Greater Frenchtown/Southside District along Osceola Street between Martin Luther King Jr. Boulevard and South Adams Street. The proposed sidewalk will connect the existing sidewalk on Osceola Street and Martin Luther King Jr. Boulevard to the existing sidewalk on South Adams Street. The project was approved for recommendation to the CRA Board by the Greater Frenchtown/Southside Citizens Advisory Committee (GFS CAC) at the June 10, 2024 GFS CAC meeting. The funding request will be presented to the CRA Board as an agenda item at the August 22, 2024 meeting.

## **DOWNTOWN DISTRICT (DT)**



Argonaut Coffee - 850 S Gadsden St, Suite 106

Argonaut Coffee, LLC was granted \$101,813 in CRA funds to assist with the completion of exterior and interior renovations at 850 S Gadsden Street, Suite 160. The requested grant funds will be used to complete additional improvements to the interior and exterior of the space including a pergola over the exterior seating area, a metal awning over the front entrance, and an interior thin brick accent wall. The project was approved for recommendation to the CRA Board by the Downtown Redevelopment Commission (DRC) at the June 10, 2024 DRC meeting. The funding request for exterior and interior renovations to Argonaut Coffee at Cascades Park located at 850 S Gadsden Street, Suite 160 was approved by the CRA Board at the May 23, 2024 meeting.

## 10-Year Strategic Investment Plan

In April 2024, the Tallahassee CRA conducted two DT 10-year Strategic Investment Plan community workshops and had an on-line survey available for Downtown stakeholders. At least 75 individuals attended the workshops and over 425 stakeholders completed the on-line survey. The information and data received is currently being used to develop a draft strategic investment plan. The draft will be discussed at a DT DRC meeting in the Fall of 2024 and final disposition by the CRA Board is anticipated to occur Fall 2024 or early Winter 2025. The goal is to prioritize potential projects, funding and identify where the community would like to see the CRA focus their efforts.
